Experience

Prevailed at the U.S. Court of Appeals for the Ninth Circuit for **Shopify Inc.** in a published decision, on a matter of first impression, limiting the reach of personal jurisdiction for internet companies. Representing a **global asset management firm** in sprawling, multi-million -dollar litigation against a former officer and director that spans multiple state and federal fora.

Representing **Shopify Inc.** in multiple class action lawsuits arising out of a data breach.

Defending **Amazon.com** and **Twitch** against multiple lawsuits arising out of the tragic May 2022 mass shooting at a grocery store in Buffalo, NY. Plaintiffs' claims, which include product liability, negligence, and other torts, raise significant issues relating to the First Amendment and the scope of immunity for social media services under Section 230 of the Communications Decency Act.

Representing **Epic Games** in cases across multiple jurisdictions claiming that the company intentionally designed its games to addict players. (See "Activision, Epic, Video Game Developers Face Addiction Suit," **Bloomberg Law**).

Represented a **Fortune 500 oil and natural gas operator** in litigation in the Delaware Court of Chancery arising out of a failed merger agreement, which resulted in a favorable judgment in excess of \$600 million.
